- (4) A member of the MAC Committee discusses the proposal with me/us.
- (5) If the proposal is agreed to, both MAC and I/we sign the agreement and the process is done.
- (6) If the proposal is not agreed to, the MAC Committee meets to discuss any extenuating circumstances, and either makes changes to the proposal or uses the original figures.
- (7) **I/we agree to the use of my/our VISA® or MasterCard® credit card supplied in this application for both the initial \$180.00 application fee and in case an agreed-upon payment is not paid in a timely manner. Failure to provide a valid card, or allow GLT to use the card under these circumstances immediately voids your MAC agreement with GLT.**
